On 04/14/04, Deputy W.T. Myrtle, along with Sgt. W.P. McNett were dispatched to 998 Woods Chapel Road, New Market VA, for a reported disturbance. According to the complainant, Jessica Whittington (59 McGarvey Road, Edinburg VA) her sister, Megan called her and told her that her live-in boyfriend assaulted her.

Myrtle and McNett arrived and met with Megan Whittington. According to Whittington, her live-in boyfriend, Dustin Stanley was upset with her because she would not watch food on the stove that he was fixing. Whittington told Myrtle that D. Stanley became argumentative with her and then it turned physical. She told Myrtle that D. Stanley slapped her about the head area and pushed her on the bed and pulled her hair. Myrtle observed Whittington to be very emotional and crying, however did not see any physical marks. Whittington provided a written statement of the event.

Myrtle then spoke to Timmy Stanley, D. Stanley's brother. T. Stanley told Myrtle the same story and provided Myrtle a written statement of the event. T. Stanley also told Myrtle that he told D. Stanley to stop "beating" on Megan several times.

D. Stanley left the residence prior to Myrtle's arrival. Myrtle left the residence and went to the Shen Co Jail and met with Magistrate Allen. Myrtle went before Allen and secured one warrant charging D. Stanley with violation of VA State Code 18.2-57.2, Assault and Battery of a Family or Household Member. Myrtle also petitioned for an Emergency Protective Order. Stanley is scheduled to appear in Shen Co JD CT on 05/26/04 at 9:00 AM.
