On 2/8/05 Deputy W.T. Myrtle was dispatched to 400 Water St., Apt. 4, Edinburg, VA for a reported disturbance. ECC advised Myrtle that an unknown caller had called from out of state and reported an alleged assault that had occurred at the residence.

Myrtle, along with Sgt. L.L. Sherfey and Deputy M.S. Miller, arrived at the residence. Myrtle spoke to 15 year old [REDACTED]. [REDACTED] told Myrtle that Dustin Stanley had assaulted him. [REDACTED] stated that he and Stanley had a verbal disagreement at which point Stanley had grabbed [REDACTED] and threw him to the ground. Myrtle observed an approximate 1 inch laceration to the underside of [REDACTED] left arm. There were no other witnesses to the alleged assault and Stanley had left prior to Myrtle's arrival. Myrtle photographed the injury to [REDACTED] arm.

Myrtle, along with Sherfey and Miller, canvassed the area in an attempt to locate Stanley with no success. Myrtle proceeded to the magistrates office and went before Magistrate Kennedy. Myrtle secured a warrant against Stanley for violation of VA State Code section 18.2-57, assault and battery. Once served, Stanley is scheduled to appear in Shenandoah County J&DR District Court on 3/3/05 at 9:00 AM.
