On 06/23/03, Deputy C.S. Valentine and Deputy T. Frazier were traveling north on Main Street in the town of Woodstock. Valentine and Frazier observed four white males physically fighting on Main Street in front on Fink's Jewelers. Valentine later identified the males as Dustin Stanley (998 Woods Chapel Road), Michael Bucklew (12942 Old Valley Pike), Timothy Lee Miller (1596 Hoover Road) and John Dale Whittington (213 West Court Street, Apt. 2).

Valentine observed all four males fighting and Dustin Stanley was on the bottom of the pile. Valentine and Frazier identified themselves and attempted to stop the fight. Frazier attempted to secure Dustin Stanley but Stanley continued to resist Frazier. Valentine lost control of Miller and Miller ran toward Stanley. Stanley got away from Frazier and ran toward Miller. Stanley punched Miller in the face and Miller fell to the ground. Frazier had to physically restrain Stanley and Valentine tried to restrain Miller. Miller got off the ground and ran toward Valentine, Frazier and Stanley. Miller was very angry so Valentine had to push him away. Valentine tried to keep Miller under control but he would not calm down and ran toward Valentine again so Valentine sprayed Miller with pepper spray. After Valentine sprayed Miller he did lay on the ground. Valentine was able to secure Miller, Whittington and Bucklew in handcuffs. Valentine had to assist Frazier with Stanley who was very out of control. Woodstock Police Officers assisted Valentine and Frazier by walking Miller, Whittington and Bucklew to the Shen Co Jail.

Valentine later transported Stanley to the jail. Valentine interviewed Vickie Stanley and Annberly Whetzel who both witnessed the fight. Both witnesses observed all suspects fighting. Whetzel said she got assaulted by Timothy Miller and Whittington while she was trying to stop the fight. Vickie Stanley also was assaulted when trying to assist with stopping the fight. As the jail officers put Stanley into the holding cell, Timothy Miller used his head and struck Stanley in the eye. Miller and Stanley both had a strong odor of alcohol on their breath.

Stanley and Miller were charged with violation of VA State Codes 18.2-57, Assault and Battery and 18.2-415, Disorderly Conduct. Whittington and Bucklew were charged with violation of VA State Code 18.2-415, Disorderly Conduct. Court dates set for 07/18/03 at 9:00 AM in Shen Co GD CT.
