

1 Q. And were you aware or not whether the relationship
2 was terminating with your brother?

3 A. Yes, ma'am.

4 Q. It was terminating?

5 A. Yes, ma'am. I knew that Dustin, he told me he
6 wasn't going back.

7 MR. ALBERTSON: Judge, I object.

8 Q. That's fine. You were aware their relationship
9 was terminating.

10 A. Yeah.

11 Q. Thank you. Answer any questions Mr. Albertson
12 has.

14 Cross Examination by Mr. Albertson:

15 Q. Mr. Stanley, when was this first phone call where
16 you talked to her and she said about him pissing her off?

17 A. It was about June 27th. She had made reference in
18 many phone calls before that. That was the first time
19 that she had actually mentioned a gun.

20 Q. Was that to your cell phone?

21 A. Yes, sir.

22 Q. And do you have the same cell phone now?

23 A. Yes, sir.

24 Q. Have you provided the police that cell phone
25 number?

1 supposed to be coming back to Bryce to hang out. And
2 somewhere along the line they got into an argument and
3 she dropped Dustin off. Said that Dustin had got out of
4 her vehicle and left walking. She went to the place
5 where he was going, where he was intending to be dropped
6 off. Another argument escalated there. My brother left
7 walking.

8 Q. And were you there?

9 A. No, ma'am.

10 Q. She's recounting this to you, telling you this?

11 A. Yes, ma'am.

12 Q. And what does she then tell you she's going to
13 do?

14 A. She told me over the phone, she said your brother
15 really pisses me off when he acts like this. I just
16 don't know why he has to act this way. I actually, she
17 said you know Josh I actually found myself in a store
18 yesterday looking at guns trying to pick out the one I'm
19 going to shoot your brother with.

20 Q. And what did you say to Ms. Hockman when she made
21 this comment to you?

22 A. I told her that wasn't funny, I didn't appreciate
23 her saying that, not to even joke about stuff like that.

24 Q. Did you think she was joking at that time?

25 A. Yes, ma'am. I didn't take it as a serious threat

1 Q. And did she identify herself as Donna or Donna
2 Hockman?

3 A. Yes, ma'am.

4 Q. What did Ms. Hockman tell you on that June 27th
5 date?

6 A. Her and Dustin had had a, had an argument. Dustin
7 wanted to be taken and dropped off somewhere. She had
8 taken him and dropped him off. The conversation persisted
9 on, Donna talking about my brother. You know, I can't
10 stand him. He just pisses me off. He does this, he does
11 that. And then she made reference to when he gets, when-
12 he acts like this and he pisses me off I think about
13 killing him. I actually found myself in the gun store the
14 other day. Well, she didn't say gun. In the store the
15 other day looking at guns to pick out the one I'm going to
16 shoot your brother with.

17 Q. And what did you say to her regarding this?

18 A. I told her hey, that's, you know, you've gone too
19 far. You need to shut up. That's not even funny to joke
20 about. That's not even funny to talk about. Don't ever
21 say that to me again. And then I told my brother about
22 it.

23 Q. But he continued the relationship with her, is
24 that correct?

25 A. Yes.
