Captain Wittig next traveled to the scene of the homicide to assist the on site Investigators. Shortly after arriving at the scene Captain Wittig was approached by Corporal K. T. Hensley. Corporal Hensley told Captain Wittig that a telephone call had been patched through to her cellular telephone from Doctor Folsom, the Harrisonburg/Rockingham County Medical Examiner. Corporal Hensley advised Captain Wittig that Doctor Folsom was inquiring as to the status of the investigation.

Captain Wittig spoke with Doctor Folsom providing Doctor Folsom with the up to the minute details of the investigation as Captain Wittig understood them. After receiving this information Doctor Folsom, at approximately 1940 hours, advised Captain Wittig that he was in the Washington D. C. area with his family but that when Investigators wanted to move the body that the Investigators had his authorization. Doctor Folsom advised to have the body transported to the Rockingham Memorial Hospital and placed in the morgue and that he would conduct a preliminary examination of the body on Saturday at 1800 hours. Captain Wittig passed this information along to case agent, Investigator Spitler and Lieutenant Brown.

While at the scene a vehicle pulled into the driveway and stopped. Investigator S. B. Scholten, who was assisting with security at the scene contacted Captain Wittig that the person who had just arrived might have pertinent information in regard to the homicide.

Captain Wittig met with that person identifying that person as Brandon James Harter who provided a date of birth of [REDACTED], a social security number of [REDACTED] and a residence address of [REDACTED]. The following is Captain Wittig's understanding of the information furnished by Mr. Harter in a brief interview conducted.

Mr. Harter told Captain Wittig that Donna Hockman was a very good friend of his and that he knew Dustin to be a dangerous person. Mr. Harter stated that on one occasion a while back that Dustin had threatened him sending the threat via a text message and that this had caused Mr. Harter to end a relationship with Hockman.

Mr. Harter told Captain Wittig that this afternoon Hockman called him while police officers were at the residence. Mr. Harter stated that Hockman asked him to contact a lawyer for her which he did. Mr. Harter further stated that during the brief telephone conversation that Hockman "said she used a gun" but did not elaborate or go into detail.

Mr. Harter told Captain Wittig that Hockman's ex-husband was a police officer in the Winchester, Virginia area and that he had telephoned the ex-husband on numerous occasions leaving messages for the ex-husband that Hockman's life was in danger from Dustin. Mr. Harter told Captain Wittig that the calls were never answered.

At some point in the investigation it was decided that Hockman's son, Kris, could leave the residence. Kris will be fully identified in a report from Investigator Spitler. Captain Wittig met with Kris who was seated in Investigator Spitler's vehicle. Kris provided Captain Wittig with two contact telephone numbers for his father, David George. The provided numbers were (540) 325-1029 and (540) 459-7758. Captain Wittig made contact with Mr. George, asking Mr. George to come to the Grassland Lane address to take charge of Kris and transport Kris. Mr. George advised Captain Wittig that he would respond immediately.

At approximately 2025 hours Mr. George arrived at the Grassland Lane address to pick up Kris. Captain Wittig allowed Kris to say good by to Hockman prior to Kris leaving with Captain Wittig

standing in close proximity to the two people while they said their good bys. Kris then went to sit in Mr. Georges vehicle while Captain Wittig spoke with Mr. George.

Mr. George was fully identified as David Ashley George, providing a date of birth of 10/11/68, a social security number of [REDACTED] and a residence address of 2367 Fravel Road, Woodstock, Virginia, 22664. The following is Captain Wittig's understanding of the information provided by Mr. George in a brief interview.

Mr. George told Captain Wittig that he has never met Dustin and the only information he could provide about Dustin would come from what Kris has told him. Mr. George stated that Kris has said that Dustin is "not a nice person" and that Dustin used "loud words". Mr. George said that Kris has also said that Kris believed that Dustin could be a violent person and that he believed that Dustin had been violent with others in the past. When asked by Captain Wittig Mr. George stated that Kris never said that Dustin had ever hit Hockman and Kris never stated that he feared Dustin.

At approximately 2058 hours it was decided that notification of Dustin Stanley's next of kin should be made. Captain Wittig took this assignment due to the other Investigators being busy executing the search warrant and gathering evidence. Captain Wittig first placed a telephone call to the Shenandoah County ECC. Captain Wittig had been provided with the information that Stanley's relatives lived in Mt. Jackson on Main Street across from some storage units.

Captain Wittig provided the Shenandoah County ECC operator with Dustin Stanley's name and inquired if there was any address attached to Stanley in the Mt. Jackson area. The operator advised Captain Wittig that there was an address in their system attached to Stanley in the Mt. Jackson area and provided that address to Captain Wittig as 7075 Main Street.

Captain Wittig asked the ECC operator to make contact with the on duty police officer working in Mt. Jackson and have that officer contact Captain Wittig by telephone. A short time later Captain Wittig received a telephone call from Mt. Jackson Police Department Sergeant J. D. Fadley.

Captain Wittig provided the address that the ECC operator had provided Captain Wittig and also provided Sergeant Fadley with Dustin Stanley's name. Sergeant Fadley told Captain Wittig that he was familiar with Stanley but said that the address should be 5075 Main Street because that is where Stanley's mother and grandmother reside.

Captain Wittig explained the circumstances of the need to make contact with the Stanley family and Sergeant Fadley agreed to assist Captain Wittig upon Captain Wittig's arrival in the town of Mt. Jackson.

A short time later Captain Wittig met with Sergeant Fadley in Mt. Jackson. Sergeant Fadley advised Captain Wittig that he had been by the Stanley residence but that the only one home was the grandmother, Grace Stout and that she was in bad health. Captain Wittig decided to not make notification to Ms. Stout.

~~After making some lengthy efforts to attempt to find a contact telephone number for Vickie Stanley, Captain Wittig and Sergeant Fadley made contact with Grace Stout at the residence. Captain Wittig advised Ms. Stout that Captain Wittig needed to speak with Vickie Stanley and inquired of Ms. Stout if she could provide Captain Wittig with a cellular telephone number for Vickie. Ms. Stout eventually did provide a cellular telephone number of (800) 622-0034.~~

Captain Wittig and Sergeant Fadley went to the storage units located in close proximity to the
