7 testified as follows:

9 Direct Examination by Ms. Garst:

10 Q. Good morning, sir.

11 A. Good morning.

12 Q. State your full name, please.

13 A. Eugene Franklin Stanley, Jr..

14 Q. Do you go by a nickname, Mr. Stanley?

15 A. Yes.

16 Q. What is it?

17 A. E.J..

18 Q. E.J., okay. What is your relationship to Dustin
19 Stanley?

20 A. He's my brother.

21 Q. And are you the youngest of the five brothers?

22 A. Yes.

1 Q. Do you see that woman here in court today?

3 Q. Can you identify her for this jury?

4 A. She's right here.

5 COURT: The record will reflect that the
6 witness has identified the defendant.

8 brother's murder on July 24th of 2008 whose residence
9 were you at when you met up with your brother that night?

10 A. We were at Nikki's.

11 Q. And what's Nikki's full name just so the jury
12 knows?

13 A. Nikki Orebaugh.

14 Q. Does she go by Riffey, her married name?

15 A. Well, yeah, Riffey. I'm sorry. Yeah, she is
16 married.

17 Q. She's married. Okay.

18 A. That's right.

19 Q. And, sir, do you recall going with your brother
20 somewhere that night?

21 A. Yes.

22 Q. And who transports you?

23 A. Donna did.

24 Q. Okay. Donna Hockman?

25 A. Yeah, Donna Hockman.

1 Q. And what's she driving, Mr. Stanley?

2 A. We were in her BMW.

3 Q. Okay. Now, where do you go, sir?

4 A. We went to our friend Brian Heister's house.

5 Q. Brian Heister?

6 A. Yes.

7 Q. And about what time do you arrive at Mr.

8 Heister's house to the best of your recollection?

9 A. I want to say it was around maybe 8:00.

10 Q. Where did he live in connection to Woodstock?

11 A. He lived on Millertown Road.

12 Q. Out of town then?

13 A. Yeah, out of town.

14 Q. Okay. Now, sir, did you happen to hear Donna
15 Hockman make a statement to your brother regarding an
16 argument that night?

17 A. No.

18 Q. Did you hear them argue at all?

19 A. No.

20 Q. Answer any questions--well, before I ask you
21 that, what time did you end up leaving the Heister
22 residence?

23 A. I want to say it was around 11:00.

24 Q. Okay. And did you ever know a woman by the name
25 of Melissa Loker or know of her?
