2 A. Non-payment.

3 MS. GARST: No other questions of this
4 witness. He's released.

5 COURT: You're released. You're free to
6 leave.

7 A. Thank you.

8 MS. GARST: Special Agent Eric Flagg.

9 CLERK: Raise your right hand, please. Do
10 you solemnly swear or affirm the testimony you are about
11 to give will be the whole truth and nothing but the
12 truth, so help you God?

13 S/A FLAGG: Yes, ma'am.

15 S/A ERIC FLAGG,

16 having been called as a witness, was duly sworn, and
17 testified as follows:

19 Direct Examination by Ms. Garst:

20 Q. Good afternoon, sir.

21 A. Good afternoon.

22 Q. State your full name, please.

23 A. Eric Flagg.

24 Q. Mr. Flagg, how are you employed?

25 A. I am a special agent with the Bureau of Alcohol,

1 Q. Agent Flagg, when you signed up Dustin Stanley he
2 actually signs a paper agreeing to be a confidential
3 informant?

4 A. Yes, he did.

5 Q. Is that a blue form or is it . . .

6 A. It's a white piece of paper. It's a typical
7 bureau form we use.

8 Q. And does it have a heavy monogram or is there a
9 seal, anything that is unusual?

10 A. I mean it's just, it does indicate it's an
11 agreement with an individual and the Bureau of Alcohol,
12 Tobacco and Firearms.

13 Q. Okay, all right. Now, Agent Flagg, as well you
14 were notified of Dustin Stanley by Lt. Thomas, is that
15 right?

16 A. Correct.

17 Q. And did you actually go to the jail to meet with
18 Dustin Stanley about his knowledge and that sort of
19 thing?

20 A. Yes, I did.

21 Q. You were the one though that made the arrangement
22 with the Court to get him out of jail?

23 A. Yes, sir.

24 Q. And without getting him out of jail was he
25 scheduled to be released any time soon to your knowledge?

1 A. Not that I know of.

2 Q. Sir, thank you for answering my questions.

3 MS. GARST: Brief follow up.

5 Re-Direct Examination by Ms. Garst:

6 Q. Was this good and useful information to the ATF,
7 Special Agent Flagg?

8 MR. ALBERTSON: Objection, relevance.

9 MS. GARST: He got him out of jail. I
10 think I can ask that question. Mr. Albertson asked did
11 he secure his release.

12 COURT: Yes. I believe that's correct, Mr.
13 Albertson. That's what I recall.

14 MR. ALBERTSON: What's that?

15 COURT: Whether he was released.

16 MR. ALBERTSON: I asked if he was released.
17 *Re*
18 Regardless of whether he gave good information or bad
19 information at this point it's irrelevant.

20 MS. GARST: Judge, he met with him, I
believe the testimony if I recall . . .

21 COURT: Ms. Garst, I'll allow you to ask
22 that one question.

23 MS. GARST: Yes, sir.
