On 12-15-08 the writer went to the Shenandoah County Sheriff's Office to speak with Lt. John Thomas of the criminal investigations unit. This was to find out about information that Commonwealth Attorney Marsha Garst received about Dustin Stanley working as a confidential informant. Lt. Thomas advised that back on January 15<sup>th</sup> 2008 he spoke with Dustin at his office. He advised that Dustin had been arrested on a charge and was looking to help himself. Lt. Thomas advised that he was working a gun larceny and the information that Dustin provided on that was going to lead him into another state. Because of crossing state lines Lt. Thomas brought in Alcohol Tobacco and Firearms agent Eric Flag. He stated that Agent Flag spoke with Dustin and gave him information but was unsure if money was ever paid for the information. Lt. Thomas stated that on the Wednesday before Dustin was murdered that he (Dustin) came to the Shenandoah County Sheriff's Office requesting to speak with Lt. Thomas. Lt. Thomas advised that in was in the middle of an interview at the time and was unable to meet with him and stated that Dustin left a message that he would contact him later but never did.

2 Q. State your full name.

3 A. John Thomas.

4 Q. Mr. Thomas, how are you employed?

5 A. I'm employed by the Shenandoah County Sheriff's  
6 Office. I'm a lieutenant in charge of criminal  
7 investigations division.

8 Q. And, sir, back in June of '08 did you meet a  
9 young man by the name of Dustin Stanley?

10 A. Yes, ma'am.

11 Q. In what capacity did he work with you?

12 A. He was working trying to recover some stolen  
13 property, providing information.

14 Q. Okay. And as providing information was he being  
15 paid for that information?

16 A. No, ma'am.

17 Q. And he didn't have any pending charges, correct?

22 some firearms had been taken and he had information on  
23 some of the individuals who may be in possession of some  
24 of those firearms and possibly being transported outside

2 with a special agent with the ATF as well?

3 A. Yes, ma'am, I did.

4 Q. What was the name of that agent?

5 A. Eric Flagg.
