

**Keith Langhorne** - (703) 980-4931 - Mr. Langhorne advised that Dustin Stanley had worked for him in mid summer but that he had eventually fired Stanley because Stanley "was hard headed, refused to do what he was told and acted as if he knew everything. Mr. Langhorne stated that Stanley came to work with another individual, **George**, and that Mr. Langhorne had knowledge that Stanley was in a relationship with **George's mother**. Mr. Langhorne said that **George** told him on one occasion that Stanley had hit his mother. Mr. Langhorne advised that he would have kept **George** working for him when he fired Stanley but that it appeared that the two needed each other. Mr. Langhorne explained that remark by saying it appeared that **George** relied on Stanley to get work and that Stanley relied on **George** for transportation. Mr. Langhorne stated that his only interaction with **George** was over the telephone when **George** had called inquiring about **George** working for him. Mr. Langhorne advised that he thought this odd giving **George** age.

Mr. Rodriguez said that he remembered **George** and that it seemed to him **George** and Stanley got along well. Mr. Rodriguez has never met Hockman.

**Raymond Keller** - (814) 207-8139 - Mr. Miller advised that he was family to Dustin Stanley explaining the relationship as Mr. Miller's wife and Dustin's mother were sisters. Mr. Miller had no information to offer.

**Dorothy Phillips** - (208) 280-3 - Ms. Phillips advised that she was a representative of Shen Valley Masonry. Ms. Phillips stated that Dustin Stanley never worked for them but Amy have applied for a job and that would be the reasoning for Stanley having the telephone number.

**Adrianne Kirkland** - (703) 314-6009 - Ms. Kirkland advised that she owned property at Bryce Resort and had come to know Dustin Stanley through that property. Ms. Kirkland stated that she had met Stanley who wanted to do some masonry work for her and had provided a business card and a website for her to access to view his work. Ms. Kirkland said she was unable to access the website and called Stanley leaving a message for him to call her. Ms. Kirkland advised that an hour later she received a telephone call from **Hockman** who in no uncertain terms wanted her to know that **she was Stanley's girlfriend**. Ms. Kirkland perceived the call from **Hockman** in somewhat and accusatory and possessive manner. Ms. Kirkland stated that later Stanley called and apologized for **Hockman's** call and said that he, **Stanley** wanted to get away from his girlfriend but was having a hard time doing so. When asked Ms. Kirkland stated that Hockman appeared to her to be not trusting of Stanley and **very possessive**. Ms. Kirkland digressed somewhat telling of meeting Stanley on Mother's Day 2008 where Stanley told her that he had just taken his mother, his grandmother and his girlfriend to brunch. At this meeting Ms. Kirkland said Stanley holding his hand over his heart had commented that he loved his girlfriend and felt something special for her in his heart. The mothers day call predated the call where the negative comment was made. Ms. Kirkland provided additional contact numbers. **Martha (Secretary Blessed Sacrament Church)** - **Martha** did not know Dustin Stanley or Donna Hockman. Martha stated that the telephone number in the wallet may have been connected to the church's food pantry or the soup kitchen.

**Carol Rosen** - (540) 325-8441 - Mr. Rosen advised that she has Richard Miller, Stanley's uncle doing odd jobs for her and that Miller had provided Stanley's name and telephone number for doing some masonry work for her. Her only contact with Stanley was job related
